

## Exemption Categories

- Subpart B: Studies involving pregnant women, fetuses & newborns are eligible for Exempt Under All 8 Categories
- Subpart C: Exemptions DO NOT apply to research involving prisoners, except for research activities involving a broader subject population that only incidentally includes prisoners
- Subpart D: Children are allowed in categories 1, 2, 3, & 4 & 5 & 6 & 7 & 8 & 9 & 10 & 11 & 12 & 13 & 14 & 15 & 16 & 17 & 18 & 19 & 20 & 21 & 22 & 23 & 24 & 25
